SUGGESTED SALARY INCREASE FOR FEDERALLY APPOINTED JUDGES

Hon. John N. Turner (Minister of Justice): I am aware of the arithmetic, Mr. Speaker.

USE OF DRIFT STATIONS IN ARCTIC RESEARCH

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): I wish to answer a question asked by the hon. member for Edmonton Centre a few days ago about research in the Arctic.

The nearest parallel in Canada to the use of to talk to them about the drift stations is the polar continental shelf hon. member has outlined.

project. This long-term project was initiated by the Canadian government in 1958 to carry out a detailed scientific investigation of that part of the Arctic Ocean adjacent to the Canadian Arctic Archipelago. By using bases on the islands and seasonal stations on the ocean, scientific work is being carried out over the continental shelf and beyond, into the polar basin, without the need for yearround drift stations. Last summer some 150 scientists and support staff, mainly involved in geophysical investigation, were working from these bases. This does not include programs within the Arctic research Archipelago or in the northern parts of the mainland of Canada.

TRANSPORT

REMOVAL OF "ARROW" HULK-RESPONSI-BILITY FOR COST

Mr. Robert McCleave (Halifax-East Hants): My question is for the Minister of Transport. Has the government or the Department of Transport decided what is to be done with the derelict portion of the *Arrow*? Also, who is to assume the cost of removing the remaining hulk?

Hon. Donald C. Jamieson (Minister of Transport): The second part of the question, Mr. Speaker, is simple to answer. Any costs involved in removal would be for the account of the ship owner. As to whether it should be moved, a decision is now being made to determine whether it is better to move it or leave it where it is in view of the relative hazard in both sets of circumstances.

EFFECT OF REDUCTION IN CLERICAL SERVICES BY CPR

Mr. David Orlikow (Winnipeg North): I have a question for the Minister of Transport. Has the minister's attention been drawn to a decision of the CPR to reduce expenditures for clerical services by 10 per cent? If so, will the minister discuss with the CPR the effect of this policy on the services provided by the company, on the communities affected and on the large number of employees who will be dismissed?

Hon. Donald C. Jamieson (Minister of Transport): Mr. Speaker, I have not been officially advised by the CPR of any such move. I have received indirect information to that effect. Of course, the CPR is not in effect obliged to tell me anything, but I will be glad to talk to them about the effects which the hon. member has outlined.
