

### LABOUR CONDITIONS

#### LAY-OFFS BY GENERAL INSTRUMENTS CORPORATION, SYDNEY, N.S.—GOVERNMENT ACTION

**Mr. Robert Muir (Cape Breton-The Sydneys):** Mr. Speaker, my question is for the Minister of Industry, Trade and Commerce. I presume that the services of different departments of the federal government have already been offered or used, but I will look into this immediately.

#### NORTHUMBERLAND CAUSEWAY—RECONSIDERATION OF DECISION NOT TO PROCEED

We would like to know what they have in mind. It is our intention to enter into discussion with the province as soon as possible.

**Mr. Macquarrie:** Mr. Speaker, I might ask the minister whether he does not consider that the resources of the government of Canada are a little more ample than those of Prince Edward Island?
