reports resulting from inquiries commissioned under the Inquiries Act do in fact belong to the people of Canada, and not to the Government of Canada, and provides that the commissioners shall, within 15 days after completion of a report, table the same and that members of Parliament under a certain procedure may call for the production and debate of that report. There is a proviso, however, that there will be an exception if the report contains matters relating to security, and if it is so stated by the commission, that shall be accepted.

Motion agreed to, bill read the first time and ordered to be printed.
