SUGGESTED NEED FOR CHANGE IN TEMPORARY ABSENCE AND PAROLE SYSTEM—GOVERNMENT POSITION

In light of an incident that happened yesterday in the province of Quebec in which a prisoner from Cowansville Penitentiary on leave of absence so-called forced a citizen at knife point to take him 50 miles to the city of Montreal and the escape by that prisoner, and in view of the suggestion in the Speech from the Throne that greater priority would be given to the protection of society, will the minister give consideration to changes in the administration of the leave of absence program that will prevent the kind of incident which happened yesterday and has happened all too often since the beginning of this session?

Hon. Warren Allmand (Solicitor General): Mr. Speaker, that incident is now under investigation. As I mentioned to the House, we are preparing proposals to change the parole and temporary absence system, and these will be given to the House shortly.

Mr. Eldon M. Woolliams (Calgary North): Mr. Speaker, I should like to ask the Solicitor General how many incidents of this kind we must experience before he stops investigating and starts to act?
