Mr. Knowles (Winnipeg North Centre): —will the minister arrange for an immediate investigation into this accident and take steps that will assure the people of Winnipeg that there will not be a repetition?

Hon. Jean-Eudes Dubé (Minister of Public Works): Mr. Speaker, my information is that a portion of the overhanging roof above the public entrance to the post office in Winnipeg fell during the night. Fortunately, no one was injured. Our consultants are at the present time searching for the cause of the accident, and hopefully will find a solution.

FLOAT OF CANADIAN DOLLAR—POSSIBLE CHANGE IN GOVERNMENT POLICY

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to direct a question to the Minister of Finance in respect of policy regarding the Canadian dollar, particularly in respect of the clean float policy of the government in the past. I should like to ask whether this float is still what you might say cleaner than clean, or does the expenditure of some \$300 million odd in recent months in respect of foreign exchange operations indicate that there has been some change in policy and that the float has become a little dirty?

Hon. John N. Turner (Minister of Finance): No, Mr. Speaker, there has been no change in policy. The Bank of Canada intervenes on behalf of the exchange fund only to maintain an orderly market. Sometimes that involves purchase and sometimes sale. If the hon. gentleman will look to the year 1973 he will see that the bank intervened on the other side.

Mr. Speaker: Order, please. I note that several hon. members are seeking to ask either supplementary questions on this subject or additional questions. We have already gone five minutes beyond the question period. I will try to give priority tomorrow to those who have tried to ask questions today, including the hon. member for Hamilton Mountain, the hon. member for Gaspé and others.
