### Question No. 3,770—Mr. Beatty:

On what date did Canada first participate in Intelpost and, since that date, by month (a) how many prepaid letters originating in Canada were carried by Intelpost and to which foreign Intelpost offices were they sent (b) how many prepaid letters directed to Canada were carried by Intelpost and from which foreign Intelpost offices were they sent (c) what was the cost to the Post Office of participation in Intelpost (d) what revenues to the Post Office resulted from its participation in Intelpost (e) what amount was spent on publicity to promote Intelpost?

# Mr. David Berger (Parliamentary Secretary to Minister of Consumer and Corporate Affairs): The Canada Post Corporation has informed me as follows:

The Intelpost service began operation on June 17, 1980. As to the remaining portions of the question, public disclosure of the internal operating information would provide commercial and financial information which would be of substantial value to competitors.

In addition, as Intelpost is being offered in conjunction with Teleglobe Canada, CNCP Telecommunications and a number of other postal and telecommunication administrations, disclosure of the operating information requested would release data which are proprietary to these other organizations.

Hospitalization for psychiatric purposes took place in the institutional health care centre, a provincial mental health facility or the Ontario Regional Psychiatric Centre (RPC), depending on the severity of the illness.
