#### PUBLIC WORKS

##### PROPOSED HALIFAX OFFICE COMPLEX

**Mr. Howard Crosby (Halifax West):** Mr. Speaker, my question is for the Minister of Public Works. It is with regard to that mysterious office complex for the city of Halifax. As the Minister knows, it was announced in April of 1983 as a special recovery project. It was to be a \$50 million building. One year later it was reduced to a \$30 million building. When are the 1,000 Nova Scotians who were promised jobs on the construction of this office complex by his colleague, the Minister of International Trade, going to be put to work? Is there really going to be an office complex?

**Hon. Roméo LeBlanc (Minister of Public Works):** Mr. Speaker, we have had some difficulty getting final clearance to the title of the land. I must express amazement that the Hon. Member's political bickering extends to the point where he would deprive his own region of a very important government project.

##### SITE EXPROPRIATION

**Mr. Howard Crosby (Halifax West):** Mr. Speaker, if the office complex was planned to the point where the Minister of International Trade could stand up and show models of it, why did the federal Government not even own the land in question? Why is it now expropriating the land and having the expropriation challenged in the courts of law? Why did it not consider these matters before it announced the complex?

**Hon. Roméo LeBlanc (Minister of Public Works):** Mr. Speaker, I hope the Hon. Member is able to explain to the Halifax *Herald*, which is very regionalistic in its approach to these stories, why he is not helping us solve the problem. The reality is that I was personally disappointed that a public body which should have co-operated with us to try to find a proper site, did not help us.
