CANADIAN COMMERCIAL BANK COLLAPSE—SEIZURE OF ASSETS IN CALIFORNIA

Miss Aideen Nicholson (Trinity): Mr. Speaker, my question is for the Minister of State for Finance.

Some Hon. Members: Hear, hear!

Mr. Gauthier: Don't be so happy.

Miss Nicholson: The Government has lead us to understand that the Bank of Canada has first claim on all the assets of the Canadian Commercial Bank, but U.S. regulators have seized \$255 worth of CCB assets in California and are quoted as taking the position that California residents will have first claim. Can the Minister tell us what steps are being taken to protect Canadian interests?

Hon. Barbara McDougall (Minister of State (Finance)): Mr. Speaker, let me say that the first protection for Canadian

interests is that we do not spread around misinformation picked up at lunch at the Toronto Club.

UNITED STATES FEDERAL RESERVE BOARD REPORT

Miss Aideen Nicholson (Trinity): Mr. Speaker, the Minister has said that she is trying to get the U.S. regulators to make available to this House their report of February 20 on the Canadian Commercial Bank.

An official of the Federal Reserve Board in Washington has been quoted as saying that she has not yet had a request. Could the Minister explain just what is happening?

Hon. Barbara McDougall (Minister of State (Finance)): Mr. Speaker, with reference to the request to the U.S. regulator, the article that appeared in the press today was surprisingly based on invalid information. Concerning that inquiry, I will read the telex response, and I am prepared to table it, Mr. Speaker. It reads:

The report of examination is the central tool of the supervisory process in the United States. It contains the findings of the examination, including information about specific assets and borrowers and criticisms of various aspects of an institution's operations. Confidentiality of the document is intended to respect the private business affairs of individual customers—

Accordingly, it is the policy of the Federal Reserve not to accede to requests from outside parties—

That was confirmed by telephone this morning. We are continuing to pursue other channels.

SPACE WEAPONRY

UNITED STATES STRATEGIC DEFENCE INITIATIVE— GOVERNMENT POLICY
