That is why I tendered my resignation to the Prime Minister today.

I am convinced that upon completion of the investigation, my innocence will be established.

# MINORITY RIGHTS

### ESTABLISHMENT OF LITIGANT ASSISTANCE PROGRAM

Hon. Benoît Bouchard (Secretary of State of Canada): Mr. Speaker, I am pleased to announce today, on behalf of the federal Government, a new and expanded litigant assistance program.

The advent of the Canadian Charter of Rights and Freedoms has focussed the attention of Canadians and led to a host of projects by volunteer agencies. In the Throne Speech in the fall of 1984, the Government stressed its commitment to social justice and equity for all Canadians, especially for those who,
