# COMMEMORATION OF THE BIRTHPLACE OF CONFEDERATION ACT

#### MEASURE TO ENACT

**Mr. George Proud (Hillsborough)** moved for leave to introduce Bill C–229, an act to commemorate the birth-place of Confederation.

He said: Madam Speaker, at the 1864 conference in Charlottetown, a feeling of anticipation and hope was born. This bill will fulfil the mandate by promoting symbols of a united Canada with plaques and other signs to mark sites and buildings of the Charlottetown Conference. This is a wonderful opportunity to showcase a very special event in our history while pointing toward our common goal of unity.

Motion agreed to, bill read the first time and ordered to be printed.

### MEASURE TO AMEND

Hon. Lloyd Axworthy (Winnipeg South Centre) moved for leave to introduce Bill C-230, an act to amend the Criminal Code (ministerial review).

He said: Madam Speaker, this bill is designed to deal with some of the more serious breaches of judicial review that we have seen in recent years. I speak specifically of the David Milgaard case and the Don Marshall case, where applications were made to review cases that were held up many years and there was serious questioning about the application of objectivity and independence.

This bill would propose the amending of the Criminal Code to have a special council appointed by the minister to review all these kinds of applications for reconsideration of criminal matters or cases of this kind and would provide an objective, independent review of the case.

Motion agreed to, bill read the first time and ordered to be printed.

# **FAMILY ALLOWANCES ACT**

### MEASURE TO AMEND

**Hon.** Lloyd Axworthy (Winnipeg South Centre) moved for leave to introduce Bill C-231, an act to amend the Family Allowances Act.

He said: Madam Speaker, this bill is a proposal to amend the Family Allowances Act to deal with perhaps one of the most shameful aspects of Canadian society; the extreme poverty faced by many women with children.

The Senate report that was just released a few months ago points out that close to 900,000 Canadian children live below the poverty line. What is quite clear from that report is that much of it begins in the period where pregnancy begins.

This act is designed to amend the Family Allowances Act to provide payment of the family allowance during the last six months of pregnancy to many women subject to certain conditions, and I recommend it to the House.

Motion agreed to, bill read the first time and ordered to be printed.
