JAMES CONMEE IN BOX YESTERDAY.

Testified as to Meeting Mr. Ganey and Letter's Declaration to Support Ross Government.

TORONTO CITY BILL.

Important Features Discussed by Private Bills Committee.

The Toronto City Bill was before the Private Bills Committee of the legislature yesterday morning, and some of its most striking features were passed upon, others being laid over for further consideration, the impression going out that the committee will sadly disagree the bill before it gets to the house again.

Clauses relating to the establishment of a relief fund for families of deceased firemen, the agreement between the city and the trustees of Toronto University, concerning improvements on Duncan street and to the debenture by-laws of the city, were passed, but the clause dealing with the extension of the powers of the Consumers' Gas Company and the purchase of a municipal playground were laid over for a week.

It is unlikely that the scheme to elect controllers by a vote of the whole city, and providing that no person shall be qualified for the controllership unless he has served at least two years in the city council, will be looked on with favor.
