POSTPONED THE **PEG-LEG'S TRIAL**

Brown Will Be Tried at the Spring Assizes.

Will Have Every Reasonable Opportunity to Prepare His Defense.

WEDNESDAY AFTERNOON. The question of whether or not Marion Brown, the alleged murderer of Policeman Michael Toohey, would be tried at the present assizes, was one in which great interest was taken. All the afternoon the court and corridors were crowded, until Judge Mere-

dith made an order postponing the trial until the spring assizes, which open on March 20. When Mr. McPhillips, prisoner's counsel, had finished reading the affidavits, he moved to have the trial postponed on the ground that the prisoner was not properly before the court, alleging that he had been arrested for selling liquor to Indians; that he had been illegally brought here for trial,

without having been properly extradited, and consequently the court had no jurisdiction—at least, not until the point concerning his extradition had been settled.

The judge disagreed with prisoner's counsel. He held that the prisoner was before the court for a crime committed here, and had been arrested for that crime in Canada. The point as to his

extradition was not one for the court to deal with. It was an international question. The right to demand extradition was not a private but a public right possessed by the state. If it were merely a private right, a man could demand it, but the state might not wish to demand that extradition proceedings be taken. Mr. McPhillips said he had not been

The witnesses named in the affidavits were wanted to establish an alibi, and to prove that the prisoner was not in Canada when the crime was committed. The prisoner had been specially cautions to say nothing about where he was at the time of the murder, but the evidence taken at the preliminary examination would show where he was on June 24, 25 and 26. The prisoner's counsel had had ample time to prepare for the trial, had he not held so tenaciously to the ground that Brown was improperly before the court, in not

having been extradited.

The judge said it had been claimed that the prisoner was brought here from a foreign state illegally, and that owing to the absence of material witnesses prisoner could not safely go to trial and be accorded justice. The judge attached no importance to the first claim, and said were it the only one he would not grant a postpone-ment. The second claim was of great-er moment. It was important that there should always be a speedy and inexpensive trial; but it was more important that there should be a fair trial. All other circumstances must give way to that. The crime with which the prisoner was charged was a very serious one, and the punishment a terrible one. He was a man without means, in a foreign country, and without friends, and for this reason, if for no other, the prisoner should have all reasonable time and facility to make his fullest and best defense. Whether the witnesses were or were not material, it was only fair that the prisoner should be given every chance, grant the application, postponing the trial until March 20 next. The jury expressed the opinion that when persons were indicted by the crown and honorably acquitted, the same rule as to costs should be followed as in civil actions.

DR. CHINIQUY

Archbishop of Montreal Has Shown Most Remarkable Consideration.

A Polite Note From His Lordship, to Which the Secretary of Rev. Dr. Chiniquy Replied in Kind.

Montreal, Jan. 12.-It looks as if Dr. Chiniquy was fast nearing his end. Archbishop Bruchesi addressed the following letter to Rev. J. L. Morin, son-

in-law of Rev. Dr. Chiniquy: "Montreal, Jan. 10, 1899.
"Sir,—I hear that Mr.Chiniquy is very seriously ill, and that he may soon die. Although he separated from us a long time ago. I cannot forget what he aiways remains in the eyes of the church, and I consider it a duty of my pastoral charge to write you that should he desire to see me, I would feel happy to comply with his wish. Kindly make known to the patient that I have taken this step, and accept the expression of

my devoted feelings. (Signed) "PAUL, "Archbishop of Montreal." The following reply was sent to the

archbishop: "171 Hutchison street, "Montreal, Jan. 10, 1899. "My Lord,-Mr. Morin, gripped and laid up in bed, requests me to write you, since he cannot do so himself. He, as well as his family, was deeply touched with the interest which you take in the spiritual welfare of Mr. Chiniquy. He highly appreciates the Christian courtesy of the step you have taken. I have the honor to convey to you as exactly as possible the reply of Mr.

Chiniquy to the wish expressed by you, and which was communicated to him by the reading of your letter: '1 am thankful to the archbishop, but I have definitely retired from the Church of Rome. I am perfectly happy in the faith of Jesus Christ. God and Jesus suffice me. I long for the moment of leaving.' Five persons, among whom were the nurse and myself, heard these words, distinctly repeated once or twice charge, my lord, you have acquired one more title to our respect. By preserving the convictions which he adopted 40 years ago, Mr. Chiniquy attests the sincerity of his faith. He can now only invoke the mercy of the Sovereign Judge, before whom we must all appear some day. Please accept, my lord, the assurance of my profound respect.

CHINESE PIRATES

Attack a Defenseless Crew-Many Lives

Vancouver, B. C., Jan. 12.—While a Hong Kong junk lay becalmed off Pinghoi, in Mirs Bay, two rowing boats, with ten men in each, came alongside the junk and commenced firing on the crew. There were no fire-arms on board the junk, and the crew made a gallant attempt at defense by hurling stone ballast on the pirates They were, however, overpowered, and five were killed and four wounded. At the inquest, a verdict of "Murdered by pirates in Chinese waters" was re-

turned. Tonquin papers to hand contain details of a piratical attack upon the town of Hanol. About one o'clock in the morning the alarm was raised that the town was being invaded by a band of armed Annamite robbers. The men came from the direction of Sontay, killing the postal delivery coolie on the road between Sontay and Hanoi. Several villages were attacked and pillaged en route. In Hanot they were met by native and foreign forces before any serious damage could be done. An official report states that four of the robbers were killed and six wounded, while between 70 to 80 arrests were made. The total strength of the pirati-

cal force is estimated at 200.
