## DAY CARE CENTRES

## Question No. 3,617—Mr. Herbert:

What is the estimated number of pre-school children presently in day care centres and, of these, how many are in centres that are cost shared by the government under the Canada Assistance Plan?

**Mr. Doug Frith (Parliamentary Secretary to Minister of National Health and Welfare):** The National Day Care Study in 1980 indicated that 92,423 pre-school children (12.16 per cent of children under six years whose mothers worked outside the home) were in approved day care spaces\*, including family day care spaces. It is not possible to give a precise number of children in centres being cost shared under the Canada Assistance Plan but it is estimated that at least 60 per cent of the above-mentioned number of children (that is, 55,454 children) were in such centres.

\*Approved day care spaces refer to spaces in provincially approved or licensed centres as opposed to private or casual day care arrangements.

## Question No. 4,153—Mr. Mazankowski:

For the fiscal years 1980-81 and 1981-82 (a) what amount did the government pay in total to subsidize oil imports and what amount did it pay by company (b) what were the average (i) gross costs (ii) subsidies per bbl for each company?
