The Order of the Day being read, for resuming the Debate on the Question which was, on Wednesday last proposed, That there be laid before this House a Return showing the amount of money collected for tolls, fees or rents of any kind by the Fredericton and St. Mary's Railway Bridge Company in each year, separately, up to the close of their last year's business; the amount of money paid the Dominion Government as interest on the \$300,000 loaned to the Company, and the arrears due to the 30th June, 1894, and the amount since paid, if any;

And the Question being again proposed:—The House resumed the said Debate.

Mr. Macdonald (Huron) moved, in amendment to the Question, seconded by Mr. Campbell, That the words, "also, copy of any mortgage securities held by the Government in respect of said loan," be added at the end thereof;

And the Question being put, That those words be added:—It was resolved in the Affirmative.

Then the main Question, so amended, being put,
