in the grave yard, representing to them its wild and neglected condition, and offering to expend any sums of money which might be entrusted to them, either for particular lots or for the ground generally, and to render an account annually. This circular was signed by the committee, whose names are widely known and respected. Two hundred copies sent to addresses both in England and Canada elicited very few replies and only \$40, which were expended on the lots of the contributors. The offers of annual contributions were so limited that the hope of accomplishing the object aimed at was abandoned.

The Victoria Hall was filled to its utmost capaoity with a very select audience on the occasion of the concert in aid of the harmonium. fund of St Matthew's Church. Altogether the concert was an immense success, and great credit is due Miss MacAdams for her exertions in arranging and con ducting it.

The twelfth annual meeting of the Committee of Mothers and Daughters in connection with St Matthew's Church was held November 20th. The following officers were elected for the ensuing year: Mrs. F. Montizambert, President; Miss Phillips, Vice-President; Miss L. Stewart, 2nd Vice-President; Miss L. Montizambert, Treasurer; Miss Walker, Secretary; Mr. F. Holloway, Auditor of Accounts; Mrs. Walton Smith, Mrs. McDougall, Mrs. C. Sharples, Mrs. J. Winfield, the Misses J. and C. Price, M and C. Sewell, R and F. Hamilton, Anderson, Leaveraft, and Porteous, Committee. During the year 1881-82 twenty meetings were held for the Mothers and fourteen for the Daughters. Once a month the Mothers made up material for the Indian homes in Algoma. On the other avenings they sowed for themselves, purchasing the material at half-price from the Committee. The elergy of St. Matthew's visited the meetings at the startly and held a Mission Service once a month. Teas were given to the Mothers and Daughters at Christmas and Easter, liberal supplies for which were sent by many kind friends.

OTTAWA.—The Bishop has appointed the Kev. A. W. Cooke, Incumbent of the Mission of Pakenham. to the Incumbency of Hillier, Prince Edward County, vice the Rev. J. Halliwell. The Mission of Hillier includes Wellington and Gerewgore. It is said that the Bishop cancelled the license of Mr. Halliwell, because he considered his usefulness at Hillier was gone. He was offered another mission, but did not accept it, hence the present action.

The Roy. E. Loucks, Rector of Pictou, is officiating temporarily at Wellington.

No appointment has as yet been made to Pakenham.

BARRIEFIELD.—The Rev. T. Stanton, B. A., who has been appointed to succeed the Rev. R. Garrett, has leased the residence of Mr. Martin Strachan for a parsonage. He will finally enter on the duties of the mission on Sunday, the 26th inst. The Rev. A. Spencer, Secretary of the Diocesan Synod, will perform the duty ad interim.

KINGSTON.—The Churchwardene of St. James' Church have decided upon a series of interior improvements to the church, including new systems of lighting and, heating, and remodelling of pews and wall and ceiling ornaments, which are to receive the consideration and approval of the congregation. It is intended to have the alterations made during this winter.

The choir of St. Paul's Church, Kingston, has been re-organized, with Mr. Trendell, of "B" Battery Artillery, as leader.
