AMENDMENT OF PROVISIONS RESPECTING PEACEFUL PICKETING

Mr. Thomas R. Berger (Vancouver-Burrard): moved for leave to introduce Bill No. C-89, to amend the Criminal Code.

Some hon. Members: Explain.

Mr. Berger: Mr. Speaker, this is a bill to amend the Criminal Code to prevent the section which relates to unlawful assembly, section 64, being used to curb peaceful picketing. Subsection 3 of section 64 provides an exception in the case of persons assembled for the purpose of protecting a dwelling house. This bill provides another exception in the case of persons assembled for the purpose of peaceful picketing.

Motion agreed to and bill read the first time.
