

*Inquiries of the Ministry*

**Mr. Douglas:** I wonder if the attention of the Prime Minister has been drawn to the statement of Mr. Michael Fenwick, who is a member of the Toronto advisory committee on manpower training, to the effect that the number of cases referred by the manpower department has dropped from 2,000 in the month of April to 500 in the month of September and that two of the training centres, Riverdale and Castle Frank have been closed.

**Mr. Speaker:** Order. The hon. member should ask a question.

**Mr. Douglas:** My question of the Prime Minister is, in view of the closing of these training centres and the decline in the referrals, would the Prime Minister consider that these training centres ought to be opened and the program expanded since it seems to be contracting?

**Mr. Pearson:** Apparently my hon. friend's information about the alleged decline has been gathered from newspaper reports, but I would be glad to look into the matter.

**Mr. R. W. Prittie (Burnaby-Richmond):** On the subject of unemployment, I should like to direct a question to the Prime Minister or the Minister of Labour. When can we expect some action to raise the present level of unemployment insurance?

**Hon. J. R. Nicholson (Minister of Labour):** Mr. Speaker, the matter is still receiving consideration. I expressed the hope that the house would be able to deal with the matter before the adjournment at Christmas. I can give no definite assurance. It depends upon the progress that is made with other legislation.

**Hon. Théogène Ricard (Saint-Hyacinthe-Bagot):** Mr. Speaker, in the absence of the Minister of Manpower and Immigration, I would like to direct a question to the Prime Minister. Could he tell the house if the government has taken action to provide alternative employment to the people who are out of work because of the shutdown, some time ago, of the Louiseville Shirt Company, due to massive imports of clothing from Asiatic countries?

Or perhaps I could put a supplementary question to the Minister of Trade and Commerce and ask him whether he is ready to assure the house that action will be taken so that other Canadian manufacturers will not be compelled to close down for the same reasons?
