4. What sums have been spent so far in each province for the fiscal year 1966-67?

Mr. J. C. Munro (Parliamentary Secretary to Minister of Manpower and Immigration): 1. Less than \$100,000,000 is available specifically for manpower re-training programs.

Approved federal estimates for all programs under the Technical and Vocational Training Agreement for the fiscal year 1966-67, total \$224,335,000. This amount includes provision for the following expenditure items: (a) The cost of buildings and equipment for all programs, \$142,475,000. (b) The operational cost of adult re-training programs, \$58,095,400. (c) The operational cost of other programs, including in-school technical and vocational programs, \$23,764,600.

2. The money is available for all occupational groups below the professional level.

3. The funds are distributed principally through the provincial Departments of Education but also through provincial Departments of Labour.

4. The amount spent by each province during the current year is not as yet recorded in the form requested. During the period April 1 to November 30, 1966, the amounts paid to each province, against claims for Training in Co-operation with Industry (Program 4), Training of the Unemployed (Program 5), and Training of Disabled Persons (Program 6) were as follows: Newfoundland, \$96,603; Prince Edward Island, \$68,218; Nova Scotia, \$863,765; New Brunswick, \$121,713; Quebec, \$2,334,605; Ontario, \$9,417,379; Manitoba, \$824,622; Saskatchewan, \$362,578; Alberta, \$617,464; British Columbia, \$468,901; Yukon Territory, \$90,765; Northwest Territories, nil; Total, \$15,266,613. In addition to the above claims, all provinces have claimed a total of \$73,687,588 for capital expenditures and \$13,159,967 for the operational costs of other programs.
