RICHIBUCTO, N.B.-DEFENCE OF INDIANS CHARGED WITH ILLEGAL FISHING

Mr. Howard: May I speak to the matter of urgency, Mr. Speaker? The court case relating to the charges is imminent, and the people are without funds to provide legal counsel. It is on the basis of the urgency of the decision by the government that I ask the question at this time.
