MONEY SENT TO UNITED STATES BY CANADIAN ORGANIZED LABOUR AND COMPANIES

### Question No. 1,250-Mr. Alexander:

To the knowledge of the government, how much money was sent to the United States last year (a) by organized labour in Canada (b) by Canadian companies controlled or owned by United States interests?

Mr. Bruce Howard (Parliamentary Secretary to Minister of Industry, Trade and Commerce): Statistics Canada (Dominion Bureau of Statistics) reports that: (a) In 1968, the last year for which information is available, \$41,792,000 in Canadian members' per capita taxes were paid to the United States headquarters of international unions. This included contributions of \$278,000 to pension plans administered by entities separate from the unions. (b) It is estimated that Canadian companies controlled or owned by United States interests made investment income payments to the United States of approximately \$700 million in 1970. These payments include dividends, interest on funded debt and profits of unincorporated branches.

# USE OF NRC LABORATORIES BY CONSUMERS ASSOCIATION OF CANADA AND OTHER GROUPS

#### Question No. 1,252-Mr. Thomson:

Does National Research Council allow the use of its laboratories to groups such as Consumers Association of Canada and (a) if so, does NRC charge for such service and on what basis (b) if not, for what reason?

Hon. C. M. Drury (President of the Treasury Board): In so far as the National Research Council of Canada is concerned, the answer is as follows: (a) Yes. NRC Laboratories' services are made available to companies, associations or individual as well as Government Departments and Agencies except in so far as these would conflict with private firms engaged in providing such services. Where the amount of laboratory service warrants charges being levied, it is on the basis of labour, materials, and overhead. When the services provided are of scientific interest to NRC the costs are sometimes shared by NRC and the requisitioner. (b) N/a.
