Barney Danson (Minister of State for Urban Affairs): I am advised by Central Mortgage and Housing Corporation as follows: Of the first 280 applications for the federal grant of \$500 to new home buyers, received by the London office of CMHC, (a) 263 were approved, (b) 17 were rejected, and (c) none were pending.

3. What is the projected cost of (a) additional facilities (b) additional manpower in each case?
