Hon. James Hugh Faulkner (Secretary of State): I am informed by the Canada Council as follows: For Victor-Lévy Beaulieu: Yes, as concerns the Canada Council. In 1970, a short term grant of \$750, to write his fourth novel and to do research on Jack Kerouac; in 1971, an arts grant of \$4,000 (of which only a first installment of \$1,600, was accepted) to write a book on Jack Kerouac; in 1972, a short term grant of \$2,250 to do research and write a book on the amateur writings found in the local libraries and archives of Quebec; in 1973, an arts grant of \$4,000 to write a book on Herman Melville and a novel. For Nicole Brossard: Yes, as concerns the Canada Council. In 1969, an arts grant of \$3,500 to publish a selection of poems; in 1970, an arts grant of \$3,500 to write two books of poems; in 1973, a short term grant of \$1,850 to write a novel; in 1975, an arts grant of \$6.600 to produce a text on the female body.

NOTE: In 1975, these two writers were chosen by the Selection Committee for the Governor General's Literary Awards and each therefore received \$2,500 from the Canada Council. To my knowledge, neither Victor-Lévy Beaulieu nor Nicole Brossard received other grants.
