METRIC CONVERSION OF SPORTS RULE BOOKS

Question No. 160-Mr. Mazankowski:

- 1. Was a study on the metric conversion of sports rule books conducted on behalf of the Department of Consumer and Corporate Affairs and, if so (a) what were the terms of reference (b) which sports were included (c) what was the cost (d) to what use will the results be put?
- 2. Will all sports organizations operating in Canada be required to convert their printed materials to the metric system?
- 3. Will the Government help sports leagues underwrite the costs of metric conversion and, if so, to what extent?
- Hon. Judy Erola (Minister of Consumer and Corporate Affairs): 1. No, however, a study is currently underway on behalf of the Sports Sector Committee of Metric Commission Canada.
- (a) The terms of reference, under the direction of the Sports Sector Committee are: (i) to conduct in-depth research on the status of metric usage in printed sports rule books and major competitions;
- (ii) to list and priorize those sports whose rule books are soft-converted or use imperial measurements and to choose sports on which to concentrate efforts initially, according to sector terms of reference; and (iii) to consult with chosen sports groups by acting as a resource to assist in the conversion of rule books to hard metric.
 - (b) All sports.
- (c) It is anticipated the cost will be approximately \$89,190 over a two-year period.
- (d) The data will be used as a monitoring tool by the sports sector and as a data base for further work with individual sports associations interested in changing to the use of rounded metric measurements in their rule books.
 - 2. No.
- 3. Other than the cost of this study, Metric Commission Canada has no plans to help sports leagues underwrite the costs of metric conversion.
