will total \$151 million, double the efforts of that hon. gentleman over the period of his tenure in office.

Mr. Rompkey: You have not signed two agreements in the last seven months.

Mr. Crosbie: I just told the Hon. Member it was approved by Treasury Board and approved by the Cabinet. All we have to do is to list it now and scratch our names on it. We will probably go to Newfoundland to do that so that we can be sure that the hon. gentleman and everybody else will know that it has been done. Is that negligence, neglect or indifference?

I am not sure how much time I have left. I will have to go very rapidly to put the nails into the coffin of this silly resolution, this jejune resolution, this careless resolution, this negligent resolution, this grossly negligent resolution, this conscienceless resolution, this resolution of which the hon. gentleman should be ever ashamed. It is in the same league as the resolution that was moved by Mr. Pearson years ago when the PCs got in for the first time in years and he moved that they get out and turn the Government over to the Liberals. This is the kind of resolution that this is.

Modernization of the Corner Brook mill, the Grand Falls pulp and paper mills, is a \$37 million modernization program, with \$5.6 million coming from the federal Government. The Marystown offshore service facility, an \$11 million agreement, was signed on September 28, 1984. The Cow Head facility near Marystown involves a \$7.7 million grant from DRIE. I could go on and on, Mr. Speaker. There is the freezing of container rates. This motion speaks of indifference and negligence.

Mr. Rompkey: Mr. Speaker, I rise on a point of order. Let the record show that the Marystown funds came out of the Burin Peninsula fund, which was signed when we were the Government of Canada. Let the record be straight.

Mr. Deputy Speaker: That is not a point of order, unfortunately.

Mr. Crosbie: Mr. Speaker, I know that the Hon. Member does not know the rules. They were never in the House when they were in Government, so he is not familiar with the rules. It is not a point of order. There is the freezing of container rates on Terra Transport where we took action a couple of months ago to see that the container rates were not increased as the CTC directed. We are continuing assistance to the Ace Shipping Company while that proceeds. Is that indifference or neglect? Then there is the St. John's Convention Centre. I know the Hon. Member hates to have anything go near St. John's. We know the Hon. Member for Grand Falls-White Bay-Labrador (Mr. Rompkey) was an enemy of St. John's and anything that came near St. John's. He did everything he could to keep everything away from St. John's. There was the agreement on the St. John's Convention Centre. The cost will be \$7 million, of which DRIE is putting in \$1.7 million.

There are the Town of Channel-Port aux Basques water supply facilities. The Hon. Member tried to cod the people of

Port aux Basques that they were going to pay for a water supply system, but he did nothing about it. At last, after months of effort, I have \$6.5 million from the Government to construct the new water system at Channel-Port aux Basques. Is that indifference? Is that neglect? My God, it's a miracle. There was also the combined services building at St. John's airport.

With regard to search and rescue, for years hon. gentlemen opposite were satisfied with inadequate search and rescue facilities on the east coast of Newfoundland. They did nothing. It did not matter what happened, what disaster struck or occurred. They sat on their big red what-nots and did nothing. They think they can pass a resolution here saying that we are showing indifference and negligence toward Atlantic Canada when we have improved immensely the search and rescue capability in St. John's and for the offshore with a second fixed-wing tracker aircraft, with two long-range DND aircraft and an additional helicopter based in St. John's. I do not have the time to go into all of the capability that has been assembled for offshore search and rescue work in connection with the offshore development. They want us to pass a resolution saying that we showed indifference and negligence. Why should we pass a resolution in the face of one or all the things I have mentioned, much less all of them?

There is the new Challenge '85 program. Yes, there is an unemployment problem in Newfoundland, but the people of Newfoundland know that the NDP is never going to resolve it. NDP Members can go down and look sympathetic and concerned, and I hope they are sympathetic and concerned, but Newfoundlanders know the NDP will never be doing anything about it. We are attempting to do something about it. We have a Challenge '85 program, not only to give young people jobs in the summer, but to give them experience so that they can have jobs for the rest of their lives, so that they can develop their skills and receive training. We are taking a long-range view, not the short-range political, putrid view that the hon. gentlemen opposite had over their 20 years in office. That is not indifference and negligence, but concern for people, concern for young people. We are starting to take action that will do something about it, not as the jackanapes opposite who did nothing about it.

In Goose Bay, in the hon. gentleman's district, we are going to do something. We are going to save Goose Bay. We are going to revitalize it. The North Warning System is going to help Goose Bay and help the whole of Labrador. There will be a magnificent increase in defence spending in Labrador. The hon. gentleman's Party objects to it, fights against it and quarrels. With regard to the star wars' Member in the first row, the Hon. Member for Winnipeg-Fort Garry (Mr. Axworthy), I say that star wars for him is a knock between the eyes. That will give him star wars. The Hon. Member is objecting to all of this that will help build up Labrador and the Goose Bay air base. He just sits there and lets his colleagues object to that. They object to the three long-range radar stations for the Labrador coast, the Baffin Peninsula area and the other area that will be part of that system. In the next few
