## Petitions

Order 36. It is signed by 3,740 constituents of the ridings of Durham, Oshawa and Ontario. The petitioners call upon Parliament to enact legislation immediately that will protect the life of every human being in Canada, from conception to natural death.

Mr. Vic Althouse (Mackenzie): Mr. Speaker, I have a petition from Canadians who urge the government to abandon its proposal for a goods and services tax because it is unfair and because of its lack of regard for taxpayers' ability to pay.

# VIA RAIL

Mr. Svend J. Robinson (Burnaby—Kingsway): Mr. Speaker, I have the honour to present a petition signed by residents of the Burnaby and Vancouver area, which points out that railway passenger service as carried on by VIA Rail is essential for many Canadians. It has been a part of Canada for more than 100 years, yet the Government of Canada has announced a cut of \$400 million over five years in its operating grants to VIA. These cuts will result in a serious reduction in passenger railway service and threaten maintenance, safety and jobs.

Finally, the petitioners note that the reductions in budget and service could eliminate one-third of our national passenger railway system. They therefore call upon Parliament to maintain the existing VIA network, upgrade VIA equipment and guarantee VIA Rail sufficient support to carry out its important mandate to provide passenger service across Canada.
