# Routine Proceedings

The first one is a timely one. It concerns the closure of the fish plant in Canso. It has the signatures of over 200 persons who are calling upon Parliament to intervene wherever necessary to ensure this fish plant, which is now closed, is re-opened on an urgent basis to provide employment for the more than 700 fish plant workers and 140 trawler workers from this community.

### VIA RAIL

Mr. Francis G. LeBlanc (Cape Breton Highlands— Canso): Mr. Speaker, I have a second petition to present on behalf of the students of St. Francis Xavier University, as well a separate one on behalf of the town and county of Antigonish.

It concerns the closure of the VIA Rail trunk between Sydney and Truro. I would like you to know, Mr. Speaker, that the citizens of this area have not forgotten and are still calling upon Parliament to insist that this government reverse this wrong decision.

## ABORTION

#### GOODS AND SERVICES TAX

These people are asking the Parliament of Canada to reject the federal government's proposed GST, which of course stands for the grief and suffering tax of the Conservative Party. They call upon all of us to oppose vigorously this most unfair measure of the government across the way.

Obviously it is very timely to present this petition today when the government is trying to ram this unfair tax through the House of Commons. I am proudly in solidarity with the people who have signed this petition.

Mr. Nelson A. Riis (Kamloops): Mr. Speaker, again it is my privilege to present a petition on behalf of a number of citizens from Kamloops, British Columbia; Chase, British Columbia; and Logan Lake, British Columbia, all of whom point out that the government's goods and services tax is a mean, cruel, brutal, uncaring, undemocratic, regressive tax with a special bias against western Canadians. They ask the government, for those reasons as well as others, to rethink it and abandon it.

I have other petitions but I will leave them for another day. I would like to get on to the opposition day.

These Canadians object to the goods and services tax being introduced by this government. To use the adjectives applied by the hon. member for Kamloops would be putting it mildly. These residents are outraged that the government is proceeding with this tax and call upon Parliament to reject it.
