BUSINESS OF THE SENATE

Hon. John J. Connolly: As honourable senators are aware, when we adjourned on Friday last it was felt that by this time tonight the bill respecting federal-provincial fiscal arrangements would be available for the consideration of this house. At that time I consulted with the honourable Leader of the Opposition (Hon. Mr. Brooks) about the length of the adjournment, and, all things considered, I think the guess we made was a fairly good one. However, the explosive situation in Cyprus over the weekend caused a lengthy debate yesterday in the other place. That, more than anything else, is responsible for the fact that the bill we are expecting has not as yet received complete consideration by the House of Commons.

I am informed that there is some prospect that the House of Commons will complete its consideration of the bill later this evening. It is my suggestion, therefore, that the Senate take recess, to reassemble at the call of the bell at 9.30, or shortly thereafter.

Hon. M. Wallace McCutcheon: Honourable senators, I have deep feeling for the position in which the Leader of the Government finds himself in these circumstances. I hear these things only in the corridors, but the bill would have been through if it had not been for a most explosive speech made this afternoon in the other place by one of the followers of the Leader of the Government in the Senate.

As far as I am concerned, I object strongly to the Senate being put in the position where we are going to sit around here and wait until the call of the bell at 9.30. I propose to speak on this bill. I will not speak tonight, and I think that we should now adjourn.
