



A False and Mean Insinuation Refuted.

Another Revelation of the Company's Tactics. Abuse Officials Who Do Not Knuckle

Down to Them-▲ Peep Behind the Scenes.

The Free Press on Tuesday contained this insulting paragraph:

"THE SHERIFF'S EXPERIENCE. "Sheriff Cameron received a bad scare in the East End late in the afternoon. Mr. Charles H. Ivey drove the sheriff to the scene of the trouble on Dundas street east for the purpose of giving him an idea of what was actually taking place in London. A car was just coming along and a shower of stones greeted it. Several of the stones rattled against the sides of the buggy, and the sheriff asked Mr. Ivey to at once drive him from the scene. Mr. Ivey did so. The sheriff had seen enough.

The sheriff at once wrote to the Free Press refuting the slander. His letter, which The Advertiser reproduced last night reveals some remarkable wire-pulling by the company behind the scenes. The sheriff was waited on shortly before 8 o'clock on Saturday night by a local street railway director and the company's solicitor, and was requested to read the riot act after the mayor had declined to do so. The sheriff replied that if necessary he would read the act, but he very properly desired to know the mayor's reasons for refusing. The sheriff said that if the conditions were as represented, and the county crown attorney so advised, he would not hesitate to read the act in any event. We quote from the sheriff's letter to show what

He immediately turned back into the Dundas street crowd, that had less than three minutes before attacked the cars. But no violence was here attempted towards us, and the statement that 'the sheriff asked Mr. Ivey to at once drive him from the scene,' either at this point or elsewhere, is not the fact-is as untrue as the invidious reference to me was gratuitous and unnecessary."

Everyone who knows Sheriff Cameron must be indignant at the imputation put upon his personal and official honor by the paragraph in the Free Press, which the sheriff evidently believes could have come only from the company's solicitor. The sheriff is a man of courage and promptitude, and while no one is more zealous in the discharge of his duty, he has a coolness of judgment which, unhappily for London, has been lacking in other quarters. It is shameful that he should be traduced by the company and the company's organ because he refused to be the company's tool.
