Various branches at separate sites such as are leased for M & I are all recorded as one agency called M & I. Owned and leased are recorded separately and an agency may be counted in each. Excluded properties are properties owned or leased by other agencies, properties which D.P.W. only manages, properties loaned or otherwise given without charge. Also excluded from above count are marine installations. Marine installations charged to D.P.W. include a few sites in Hamilton harbour for dredging and the Burlington bridge, where about 1,000 sq. ft. or rentable space is used as a control centre. Values are not available.
