I do not think that is an urgent matter of pressing necessity as contained in the rules. In this instance the message goes on beyond that and it deals with legislative measures. Therefore, I will indicate that it can only be presented to the House with unanimous consent of the House. Is there unanimous consent?

PROPOSED INQUIRY INTO BREAK-IN AT L'AGENCE DE PRESSE LIBRE—MOTION UNDER S.O. 43

Mr. Ray Hnatyshyn (Saskatoon-Biggar): Mr. Speaker, I too rise under the provisions of Standing Order 43. My motion is prompted by the statement last night by the Minister of Supply and Services that he thinks there is a possibility that the Quebec inquiry by the Parti Quebecois government into the circumstances surrounding the break-in at L'Agence de Presse Libre might turn into a political endeavour. This statement appears to contrast with the Prime Minister's assurance to the House that the government of Quebec "would make very sure... that the facts are brought to light". In view of the obvious concern of the Minister of Supply and Services about which particular facts are brought to light, I move, seconded by the hon. member for Lanark-Renfrew-Carleton (Mr. Dick):

That this House supports the establishment of a federal independent judicial inquiry into the APLQ affair and further directs that there be full government co-operation with the inquiry and, in addition, insists that the Minister of Supply and Services appear before the inquiry.

## DOMINION DAY

PROPOSALS FOR FUTURE CELEBRATIONS—MOTION UNDER S.O. 43

Mr. Howard Johnston (Okanagan-Kootenay): Mr. Speaker, I raise my question under Standing Order 43 on a matter of pressing and urgent necessity. Considering the extreme haste with which preparations for the Dominion Day party must proceed because of the last minute decision to hold one at all, and because of the great expense of advertising necessary to resuscitate an event that only last year was allowed to lapse, I move, seconded by the hon. member for Surrey-White Rock (Mr. Friesen):

That this House go on record as favouring an annual celebration on July 1, but that at least 50 per cent of the total annual budget allotted the event in future be distributed to those communities across the country which are also celebrating the event, and that the percentage of the budget to be allotted to television advertising be not more than half of one per cent.
