The accused, L.603054 Pte. Paul GRYWACHESKI, No. 12 District Depot, CA., Regina, Saskatchewan, an NRMA soldier of the Canadian Army placed on Active Service is charged with:

FIRST CHARGE:

Section 12 (1)(a)
Army Act.

WHEN ON ACTIVE SERVICE DESERTING HIS
MAJESTY'S SERVICE.

in that he

at Regina, Saskatchewan, at 0600 hours on the 27th December, 1944, absented himself from No. 12 District Depot, CA., until apprehended at Swan Plain District, Saskatchewan, at 1530 hours on the 26th January, 1945 by the Military Power, dressed in plain clothes, the cost of his apprehension and return to his Unit being \$6.63.

SECOND CHARGE:

Section 9 (2)
Army Act.

WHEN ON ACTIVE SERVICE DISOBEYING A LAWFUL COMMAND
GIVEN BY HIS SUPERIOR OFFICER.

in that he

at Regina, Saskatchewan, at 0915 hours on the 29th January, 1945, at the Q.M. Stores, No. 12 District Depot, CA., did not put on the uniform of the Canadian Army when ordered to do so by L.23029 S.Q.M.S. Collins, E., No. 12 District Depot, CA.

THIRD CHARGE:

Section 24 (2)
Army Act.
