FOURTH WITNESS C31009 Sgt Sherwood, J.A. of No 1 SIS Cdn Pro Corps having been duly sworn states: "I am 031008 Sgt Sherwood, J.A. I recognize the accused. On 7 Nov 44 at about 2230 hrs I was informed that the Cafe "Au Pre Fleuri" in Ghent had been broken into and articles of clothing were stolen. I went to the where I interviewed Madams Beyst and she took me to the room that had been broken into where I found that the top panel of the door leading into the room had been pushed in. On entering the room I noticed that into the room had been pushed in. On entering the room I noticed that the wardrobe was open and it contained a few articles of clothing. The doors of the wardrobe had been forced, thereby breaking the lock. Madame Beyst gave me a list of articles as follows, ten dresses, two ladies suits, two light cloth coats, one As trahan fur coat, five bottles of Picon, 4 bottles of Fernod, 4 bottles of Cognac and five other bottles of various liquors that had been stolen. On returning to the Provost det, Cpl McDonald handed ever to me 7 laides dresses, 2 light cloth coats, 2 bottles of cognac and 2 bottles of Picon. These articles were later identified by Madame Beyst as her property and were at the same time returned to her. I interviewed the accused on the morning of 8 Nov 44 identified by Madame Beyst as her property and were at the same time returned to her. I cautioned him that he need not say anything unless he wished to do so, but that whateverhe did say would be taken down in writing and might be used as evidence. We went to another Cafe, was there for about 5 minutes, I was still carrying the clothes and some of the liquor. We went outside again and I gave a dress to a girl who I had never seen before. The Provost jeep arrived and took us to their office. There was a red jacked in the clothes with the other clothes but I do not remain ber a scarf. Madame Beyst never gave us any information as to the red jacket. There was a list of the articles, made by me after I had Cross Examination by the Defence.
