War Appropriation (\$2,000,000,000) Act No. 1, 1945:

Resolution,—To provide for expenditures, loans, etc., in connection with National Defence and Security and with United Nations Mutual Aid; House to go into Committee on, agreed to, after debate, 4. Motion for Mr. Speaker to leave the Chair, moved, 67; agreed to, after debate, and on division, not recorded, 67. Progress reported from Committee of the Whole, 67, 71, 73, 76, 79, 82, 84, 87. Resolution adopted, 95. Bill No. 3 (Mr. Ilesley)—An Act for granting to His Majesty aid for National Defence and Security; 1st R., 95. 2nd R. moved, 95. Amendment (Mr. Dorion)—no money to enforce National Resources Mobilization Act and that said Act be repealed at once, 95. Amendment negatived (yeas 9; nays 124), 96. 2nd R., on division, 96. 3rd R., 96. Passed by Senate, 98. R.A., 99. 9 George VI, Chapter 3.
