Hon. Jean Marchand (Minister of Citizenship and Immigration): Mr. Speaker, I never said I would agree to increased taxes. When I was asked whether I would eventually object to them, I said that if higher taxes could be afforded, I would have no objection. This is a relative rather than an absolute position. As far as a capital gains tax is concerned, I said, pointing out that I was speaking for myself, that I was in favour of it. I have not changed my mind today.
