inter-city or commuter air strip is not feasible in view of the type of aircraft we have at the present time. I hope that is adequate assurance to the hon. member. If he wants it more specifically, I will look into the legal aspects and try to answer him.

**Mr. Brewin:** Categorically and clearly, but subject to the legal implications, is the minister prepared to give such an assurance?

**Mr. Jamieson:** I can do that since I mentioned in the statement this is the situation in so far as the current types of aircraft are concerned. If a short take-off type of land aircraft were developed it might be that the residents of Toronto would welcome it, but that is well beyond this time.

## TORONTO—LOCATION OF NEW FACILITY

**Mr. A. D. Hales (Wellington):** Mr. Speaker, my supplementary is directed to the Minister of Transport and is related to the question just asked. On Tuesday, he said that the suitable location had been narrowed down to a region generally north and west of Toronto. My question is one of clarification. Does north and west mean the same as northwest and therefore those areas which were being considered that are due west of Toronto are eliminated?

**Hon. Donald C. Jamieson (Minister of Transport):** Mr. Speaker, in the interest of ensuring that the risk of speculation is not enhanced, I would prefer to remain with the wording I used which I can assure the hon. member was chosen with as much care as possible—generally north and west. I might say that I see no good reason why individual Members of Parliament who have a specific interest in this matter might not be given a briefing by the department. I would be very happy to undertake that at some time in the near future.

## PROVISION FOR MANAGEMENT INCLUDING RESEARCH AND PLANNING AND IMPLEMENTATION OF PROGRAMS
