**The Acting Speaker (Mr. Ethier):** Before recognizing the parliamentary secretary, I must advise hon. members that when he speaks he will close the debate on second reading.

**Mr. Thomas H. Lefebvre (Parliamentary Secretary to President of Treasury Board):** Mr. Speaker, I will only take a few minutes as I have already spoken in this debate. I listened to the speeches made on Bill C-10. By the number and the quality of the interventions by members of all parties, it is apparent there is agreement that we need the office of comptroller general of Canada. We may not agree on how this office should be set up or the methods and procedures that the person filling this office should follow. However, if this bill is adopted and sent to committee this afternoon, there will be further opportunity to debate these points. Hon. members will again be invited to state their points.

I trust the bill will receive speedy passage in committee and be returned to the House for third reading. The underlying principle is accepted by all members. This office has been needed for some time. We must now do everything possible to ensure that the person already appointed to the position is given the opportunity to get to work as soon as possible on behalf of the taxpayers of Canada.

Members of all parties have shown through their speeches that they are concerned about public spending. The government is showing its concern by the recent announcements of many changes being made in an attempt to bring under control more and more the spending of the Canadian government, especially so in bringing forward this bill.

**TRANSFER OF OFFENDERS ACT**

MEASURE RESPECTING TREATIES ON TRANSFER OF PERSONS  
FOUND GUILTY OF CRIMINAL OFFENCES

**Hon. Jeanne Sauvé (for the Solicitor General) moved:**

That Bill C-21, to implement treaties on the transfer of persons found guilty of criminal offences, be read the second time and referred to the Standing Committee on Justice and Legal Affairs.
