companies to comply with the United Nations resolution calling for disinvestment in South Africa.

MARCH BY BIGSTONE INDIAN BAND, ALTA.—LACK OF
GOVERNMENT RESPONSE—MOTION UNDER S.O. 43

Whereas the Bigstone Indian Band in northeast Alberta is nearing the completion of its protest march for economic equality in which both young and old band members are demonstrating their desperate need for economic assistance by walking 400 kilometres to gain the attention of the government, and whereas the band has received no indication from the Prime Minister (Mr. Trudeau), the Minister of Employment and Immigration (Mr. Axworthy), the Minister of Indian Affairs and Northern Development (Mr. Munro), or the Minister of Regional Economic Expansion (Mr. de Bané) that the government intends to address the very serious poverty and unemployment that plague these people, despite the fact that the government's western development fund was supposed to have placed the needs of native people in the west at the top of its priority list, I move, seconded by the hon. member for Wetaskiwin (Mr. Schellenberger):

That this House condemn the government for its lack of response and compassion in this case, and demand that the government act immediately by meeting with the band so that a comprehensive plan may be developed to assist the band members to begin the arduous task of raising their standard of living and attaining economic independence.
