restrict a flow of information from each of the countries and make that flow of information subject to the wishes of each particular government. Is it the position of Canada to support that kind of policy, or is the Canadian Government going to oppose it?

Hon. Allan J. MacEachen (Deputy Prime Minister and Secretary of State for External Affairs): Madam Speaker, the Hon. Member should be in no doubt about the over-all policy of the Government of Canada with respect to the flow of information and the flow of ideas and people. We are presently undertaking in concert with other countries, very important negotiations in Madrid at the Conference on Security and Co-Operation in Europe. One of the objectives of Canada and other western countries is to ensure a greater flow of ideas and a greater flow of information. We are taking a stand, for example, against eastern European states, particularly the Soviet Union on its practice of jamming radio broadcasts, which is one of the ways of stopping the flow of information.
