Western Grain Transportation Act

Mr. Parker: I have no obligation to the Member to tell him what dates I was on that Committee. It appears that some Conservative Members—

Mr. Malone: The Member for Crowfoot.

Mr. Parker: If the Member for Crowfoot (Mr. Malone) wants to check the records he will find that I travelled on the Transport Committee and met with grain growers in Winnipeg, Regina and Edmonton. We also visited Prince Rupert.

Mr. Taylor: You must have been under the table in Edmonton because I did not see you there.

Mr. Parker: These Conservative Members seem to be so uptight about it, but there was more than one Transport Committee. There was one working with regard to the Crow Bill and there also was a Transport Committee that travelled throughout this country about two years ago. If they cannot remember that, they were not very interested in what was taking place in transportation in Canada.

Mr. Taylor: There was one in 1917 as well. Were you on that one?

Mr. Parker: We hear rumblings from the Conservatives and the Liberals but let us hear some constructive advice on how we should deal with this very important problem.

The only efficient way that we can handle our grain is to give the Canadian Wheat Board, which represents the farmers, manages the grain economy and how our grain is sold to other countries, the authority and opportunity to demand that the companies operate efficiently and that the shipping of grain is achieved quickly. We should not continue a system in which the railway companies have told the prairie farmers that the railway workers are causing all the problems, when it is the railway companies that have put the cars on sidings and delayed the transportation of grain as a result of their poor management. If there was an administrator dealing with these problems, the farmers would know first hand who to blame and would ensure that it would not happen.
