FULL INDEXATION OF FAMILY ALLOWANCE AND REPEAL OF TAX INCREASES

Mr. Neil Young (Beaches): Mr. Speaker, I have the pleasure to introduce a petition signed by residents of the Kitchener-Waterloo area in the Province of Ontario. Those petitioners state that deindexation of the universal family allowance is an unfair attack on women and families, and further state that this attack will not be offset by changes to the child tax credit and that other tax increases in the May Budget will place an unfair burden on low and middle income earners.

Mr. Rod Murphy (Churchill): Mr. Speaker, I also have the privilege to introduce a petition signed by nurses throughout Manitoba who indicate their opposition to the Government's intention to deindex partially the universal family allowance. They also call upon the Government to rescind unfair tax increases that will affect many Canadians.

Mr. Cyril Keeper (Winnipeg North Centre): Mr. Speaker, l have a couple of petitions, one bearing hundreds of signatures of people from my riding and which deals with family allowances. These petitioners point out that the deindexation of the family allowance is an unfair attack on women and families, especially single-parent mothers.

My other petition regarding the same subject is from Nova Scotia.

I have a further petition from British Columbia concerning family allowances. All of these petitioners call upon the Government to restore full indexation of family allowances.

Mr. Dan Heap (Spadina): Mr. Speaker, I have over 200 names on petitions from people resident in Spadina and other parts of Toronto who oppose the Government's Bill that would cut family allowance in future by 3 per cent of the annual increase. They point out that this is unfair compared to the generous tax hand-outs to corporations and people with high income. Therefore, these petitioners call on the House to reinstate full indexation of the universal family allowance and to rescind the unfair tax changes.
