#### **NON-SMOKERS' HEALTH ACT**

MEASURE TO ENACT

Ms. Lynn McDonald (Broadview—Greenwood) moved for leave to introduce Bill C-204, an Act to regulate smoking in the federal workplace and on common carriers and to amend the Hazardous Products Act in relation to cigarette advertising.

Some Hon. Members: Explain.

Ms. McDonald: Mr. Speaker, I am introducing for first reading a private Members' Bill which would give protection to all employees in the federal workplace, the House of Commons and all federal agencies, to all employees of airline companies, trains, and all carriers under federal jurisdiction and to the federal public which use services under federal jurisdiction, the House of Commons, the Senate and so forth to have a smoke-free workplace, and an objective standard has been incorporated into the Bill.

Finally, my Bill includes a measure to ban advertising and promotion of all kinds of cigarette products.

Mr. Speaker: Shall the Hon. Member have leave to introduce the Bill?

Some Hon. Members: Agreed.

Motion agreed to, Bill read the first time and ordered to be printed.

### HERITAGE RAILWAY STATION PROTECTION ACT

Mr. Taylor: Mr. Speaker, this Bill was introduced in the last session of Parliament, it went to committee but did not come

out of committee, one way or the other. This Bill will protect railway stations across the country that are considered of heritage value. It is high time that we had a Bill of this nature.

#### CRIMINAL CODE AND YOUNG OFFENDERS ACT
