PURCHASE OF CANADIAN PACIFIC AIRLINES BY PACIFIC WESTERN AIRLINES

Hon. André Ouellet (Papineau): Mr. Speaker, my question is for the Minister of Transport. Yesterday we learned of CP Air being purchased by Pacific Western. Does the Minister realize that in the document *Freedom to Move* his Government promised that deregulation would increase competition? Since then we have witnessed seven major takeovers in the airline industry. Is the Minister ready to allow this move to take place that will result in there being only two major airlines in Canada? Is his Government ready to allow this to take place?

Hon. John C. Crosbie (Minister of Transport): Mr. Speaker, I regret the savage attack that the Hon. Member has made upon his colleague, the Hon. Member for Winnipeg—Fort Garry, who introduced the deregulation policy with respect to air transportation three years ago.

Mr. Broadbent: You had a choice.

Mr. Crosbie: The hon. gentleman should have made his protests then when he was in Cabinet and approved that policy.

In the meantime, I think that Canada will be better served by having two healthy competitors than by having the giant Air Canada and a group of financially weak or regionally small airlines. We will have both. We will have two large competitive national airlines and a plethora of smaller regional and local airlines.
