The jurors not presenting a written report, did not explain whether the division was over conviction or acquittal for theft or receiving stolen goods. They simply reported that they could not agree, but members of the jury stated afterwards that the majority stood for conviction. stood for conviction.



Anderson Bros. Purchase "Saint Elmo"-Pay 75c Per Pound for Fine Animal.

The grand champion "Saint Elmo" of the annual Toronto Fat Stock Show was purchased by Anderson Bros. in Toronto on Friday for 75 cents per pound. Besides winning the grand prize of the show, it also carried away the first prize in the following classes: grade or cross-bred steer under one year, and an cross-bred steer under one year, and an added prize for the best grade or cross-bred steer, donated by the Aberdeen Angus Association of Ontario. This fine steer was formerly owned by G. A. Guthrie & Sons of New Dundee, Ont. It weighed 1,120 pounds. A peculiar feature with the purchase of "Saint Elmo" is the fact that this is the first time the grand champion has been sold to any person west of Toronto, and the first time any grand champion of any cattle show has been purchased by a London buyer. The steer will be on exhibition at Anderson's meat market all next week and the following week will be killed for Christmas meat for the London people.

CAUCHON TO ADVISE ON SUBWAY IN CITY

Noulan Cauchon, expert railroad engineer of Ottawa, will be asked to come to the city immediately to ad vise on designs for a subway at the Ontario Garage Company, Chevrolet G. T. R. Rectory street crossing as a result of a meeting of the specia committee on level crossings Friday afternoon.

Mayor E. S. Little laid plans before the committee, which had been prepared by Chief Engineer Mountair of the Dominion railway board. They called for a six-foot track elevation at this point and a twelve-foot depres sion. The probable cost of the subway would be \$250,000 while the track elevation would cost an additional \$30,000. This would be an integral part of any grade separation plan carried out later, and would not be wasted, he pointed out.

One of the main points to be de-cided is whether there shall be a a per cent or a 5 per cent grade. The 5 per cent grade would be cheaper, but not as suitable for traffic. A compro-mise may be reached by having a f per cent grade on the south side of the tracks and a 3 per cent grade

on the other.

Mr. Cauchon is regarded as thoroughly competent to give advice on the subject, as he is a former C. P. R. engineer, and has also had experience with the Dominion railway board. It is probable, that he will be called to wree with the Dominion railway board. It is probable that he will be asked to present the city's case to the board, as he recently prepared an extensive report on the situation here.

Mayor Little expects that Mr. Cauchon can come here early next week.


