UNE INVENTION DANS L'IMPRIMERIE

Deux Anglais auraient trouvé le moyen de substituer à l'imprimerie, avec des caractères métalliques un nouveau procédé qui supprimerait les cases à caractères, et les linotypes en usage actuellement.

L'invention consiste en des pellicules photographiques reproduisant les lettres, les chiffres, les signes de ponctuation et remplaçant les caractères correspondants. Elle transformerait de fond en comble le système d'imprimerie en usage de nos jours.

Les ateliers de typographie seraient de dimensions très réduites et les frais d'impressions diminueraient dans des proportions considérables.

La nouvelle invention a quelque analogie avec la machine à écrire. Employée avec le concours de la télégraphie sans fil et actionnée à Londres, par exemple, elle permettrait de composer des textes simultanément à Paris et à Edimbourg.

Ce qui veut dire que lorsque l'invention aura passé dans le domaine pratique, nous pourrions transmettre vos commandes d'impressions par cablogramme aux imprimeurs d'Angleterre ou de France qui exécuteront vos travaux dans nos propres ateliers par télégraphie sans fil. Ce sera le dernier choc!
