An Act to amend the Act respecting the Currency.

HEREAS it is expedient in order to facilitate the transaction of Preamble. While business, and payments of money, to authorize and render legal the tender in single payments of a larger amount of silver coin than that now fixed by law, and to make certain silver coins a legal tender: Therefore Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—

- 1. The first part of the eighth section of chapter fifteen of the Consoli-Sec. 8 of Condated Statutes of Canada, relating to payments in silver coin, is amendable and shall be read as follows: "But the silver coin mentioned in Silver to be a 10 either of the two preceding sections shall not be a legal tender to the tender up to amount of more than four hundred dollars in one payment;" and the \$400. remainder of the said section is repealed.
