- 201 From Daniel Sullivan, of the City of Saint John, praying a return of money he has been chargeable with in prosecuting a claim to Goods illegally seized by Officers of the Customs, and for inquiry into the administration of the Law in the Court of Admiralty, 502
- 202 From John Hutchinson, of Saint John, praying encouragement for improvements made by him in the mode of lighting Light Houses, as well as Machine for ringing a Bell, to be useful to Mariners and others in foggy weather, 502
- 203 From the Rector, Church Wardens and Vestry of Trinity Church, in the Parish of Kingston, praying aid to establish a Steam Ferry Boat at Gondola Point, on the Kennebecasis River, 502
