INQUIRY AS TO AMOUNT OF MAIN ESTIMATES THIS YEAR

On the orders of the day:

Mr. W. M. Benidickson (Kenora-Rainy River): Mr. Speaker, I think it will be observed that I have attempted to co-operate with the Minister of Finance and keep in order when the estimates are presented to the house. I might address a question to the minister at this time which I think is in order. The total of the statutory items and the amounts to be voted by this house last year amounted to \$5,740 million. Will the minister just indicate what the total is for this year as compared with last year?

Mr. Speaker: Order. I think the hon. member is inquiring about information which is readily available to all hon. members by looking at the document which has been tabled, and which the house has directed to be referred to the committee of supply.

Mr. Benidickson: Just on that point I would simply say, of course, that information has been made available to the representatives of the people through the press, but those of us who are sitting here performing our duties as members of parliament will not be able to leave the chamber for some time to obtain that information.

Mr. Speaker: I do not know whether the hon. member raises that as a matter of privilege; if he does, perhaps it could be commented on.

Mr. Speaker: The hon. member does not in the house whether he informed the press at an earlier hour that the proposed budgetary expenditures as contained in the main estimates tabled today total \$6,123 million as compared with \$4,526 million when his last Liberal predecessor presented estimates to the house?

We have had the practice adopted by the minister of distributing information to the press earlier this day, and at the opening of the house we were not permitted to get that information although the very subject on which the information would have a bearing is the item of government business which will occupy the rest of the sitting today.

The point that I think is worthy of consideration is whether or not some other method should be provided by the minister for making available to the members of the House of Commons that information which was made available to the press earlier today, so that members might use it where it would be properly used, in the debate on this main item of government business which is to come before us today.
