**Mr. David MacDonald (Egmont):** Mr. Speaker, my question is for the Minister of Agriculture. Some time ago it was suggested that the MacFarlane task force on agriculture would report before next year. I wonder when we will have a final report from that task force.

**Hon. H. A. Olson (Minister of Agriculture):** Mr. Speaker, there will be no final report until the end of 1969. Indeed there never has been an indication that there would be. We have asked for interim reports on certain parts of their studies so that these reports could be used as position papers for the agricultural congress which is to be held in Ottawa late in March. I believe some of these have been received and will be circulated. They will be distributed to the interested parties, the delegates to the congress. I see no reason why members of parliament could not have them as soon as they are distributed.
