Question No. 393-Mr. Herbert:

What was the total of all government expenses as a percentage of the gross national product for the years 1975-76, 1976-77, 1977-78 and, what are the estimated percentages for 1978-79 and 1979-80?

¹³ The federal government sets its spending ceiling in terms of total outlays. Total outlays is the sum of budgetary expenditures and loans, investment and advances. Savings of approximately \$700 million in 1977-78 budgetary expenditure resulted from the partial replacement of cash transfers to provinces by the transfer of additional tax points under the established programs financing arrangement. Adjustment for this change would increase the 1977-78 total outlays/GNP ratios to 20.8 per cent.

CROWN ASSETS DISPOSAL CORPORATION

Question No. 398-Mr. Bawden:

1. How many persons were employed by Crown Assets Disposal Corporation since January 1, 1978?

2. How many have left the employ of the Corporation since January 1, 1978?3. What is considered to be an acceptable level of employee turnover?

Hon. Pierre De Bané (Minister of Supply and Services): 1 and 2. Since January 1, 1978, 32 employees have left the corporation and 32 were hired.

3. An acceptable level of employee turn-over is whatever is considered to be necessary for the most efficient operation of the corporation.

Question No. 399-Mr. Bawden:

1. Does the Surplus Crown Assets Act state that revenue from sales of surplus Crown assets should be deposited to the credit of the Receiver General?

2. Were funds received for the reissue of furniture refinished by the Refinishing Branch of the Department of Supply and Services, amounting to \$286,800 in 1966-67, remitted to the Supply Revolving Fund rather than deposited to the credit of the Receiver General and, if so, under what authority?

Hon. Pierre De Bané (Minister of Supply and Services): 1. No.

2. Funds received for the reissue of refinished furniture are credited to the supply revolving fund to offset related expenses, such as the cost of collecting, receiving, documenting and warehousing surplus furniture, as well as the cost of refinish-

ing, reissuing and delivering furniture, which meets an acceptable standard.

The Crown Assets Disposal Corporation "sells" acceptable furniture to the supply revolving fund at zero value. After absorbing the costs referred to above, any profits exceeding the limitation on the supply revolving fund retained earnings are remitted to the Receiver General, Consolidated Revenue Fund.

Question No. 400-Mr. Bawden:

1. Does the Procedure Manual of Crown Assets Disposal Corporation state that all merchandise must be inspected and valued prior to sale?

2. Is all merchandise sold by Crown Assets Disposal Corporation inspected and valued prior to sale and, if not, what is the percentage per annum of goods sold and not handled in this manner?
