I am just reminded once again that we are all waiting, not with bated breath because we would be out of breath if we were to continue bating our breath like this, for this index. I hope that within a measurable period of time we will see that index to the Permanent and Provisional Standing Orders of the House of Commons.

Madam Speaker: I have to thank the Hon. Member for his patience because I know how eagerly he is waiting for this index in order to be able to refer more easily to the Standing Orders. His patience is only equal to mine because I need this index even more than the Hon. Member. I must tell the Hon. Member that the Queen's Printer is actually printing the index, but there is trouble with the cover. The last news is that 200 copies will be ready on Monday. I will be getting those 200 copies. I am not in a position to determine, but I guess they will be distributed on a first come, first served basis.

**Mr. Munro (Esquimalt-Saanich):** Is the cover coming out in a blushing red, Madam Speaker?

Madam Speaker: I have no idea!

**Mr. Baker** (Nepean-Carleton): May I respectfully suggest that the Hon. Member for Esquimalt-Saanich (Mr. Munro) get the first copy and that it be autographed by you, Madam Speaker!
